### ENTRY RULES:

1. Viewers' Choice ribbons will be given for first, second and third place.
2. You are encouraged to enter items completed since the last show in 2017. All styles of quilts – large and small, beginner and advanced are needed. Did you take a workshop? Finish it and show it off.
3. Entry fee for non-guild members is \$10.00 per quilt.
4. Entry fee for OCQG members is \$5.00 per quilt.
5. All entry fees are nonrefundable.
6. **Entry form deadline is March 12, 2019 Guild meeting.**
  - a. Payment and a hard copy photo of quilt must be included with the entry form.
  - b. A photographer will be available at the February and March OCQG Meetings to take digital photos of **the Entrants**. If you do not have your photo taken at the Guild Meeting, you must email a digital photo of yourself to Beth Ferguson at [sonclub2001@yahoo.com](mailto:sonclub2001@yahoo.com) along with a copy of your entry form.
7. Submit one entry form for each item entered.
8. All quilts must have a 4" hanging sleeve.
9. All quilts/entries must have an identification label stitched on the back, stating name of entry and name of entrant.
10. Entries must be delivered in a pillowcase or fabric bag with entrant's name on it. No Plastic bags, please.
11. **Quilts/Entries preferred to be turned at the March 12, 2019 OCQG Meeting, but no later than April 9, 2019 OCQG Meeting.**

Entry Forms, payment, and hard copy photos of quilts will be accepted by Beth Ferguson at the February and March OCQG Meetings or can be mailed directly to Beth Ferguson (address in guild directory) or OCQG, PO BOX 3108, Orange, CA 92857.

### **HOLD HARMLESS AGREEMENT**

In reference to the Orange County Quilters Guild 2019 Show “BRANCH OUT....”

1. I wish to display my entry at the Orange County Quilters Guild 2019 “BRANCH OUT ” (Quilt Show).
2. I certify that my entry described above was made by the person(s) listed above.
3. I understand that by signing this agreement I hereby grant Orange County Quilters Guild (“OCQG”) the right to use photographs of my entry for promotional purposes (including, but not limited, to advertising and multimedia presentations in both print and digital formats) as well as other legitimate and proper uses without compensation to me.
4. I agree to not hold OCQG liable for any damage to my entry or loss of my entry beyond “standard” insurance limitations.
5. I also agree to not hold OCQG responsible for any damage to my entry or loss of my entry in the Quilt Show caused by “acts of God or nature” or third party individuals beyond the control of OCQG.
6. If I require more than the “standard” insurance policy coverage for my entry then I must either add my quilt entry to my homeowner’s policy or secure additional coverage through my insurance agent. Proof of this additional coverage or coverage under the homeowner’s policy must be provided to OCQG prior to the Quilt Show.
7. I understand that OCQG will take every precaution and reasonable measure to protect my entry in this show.
